For more than 15 years, the Satilla Riverkeeper has been a non-profit advocate for the unique Satilla River. We watch out for environmental harm, we educate, and we provide assistance that can help prevent problems. The diligence, knowledge, and communication required are very costly.

The Satilla Riverkeeper has been busy in 2022 and already:

- Installed **7 new trash cans** at the Satilla River landings.
- Led a successful fishing tournament.
- **Tested the water on over 78 sites** on the Satilla River.
- **Investigated over 14 reports of pollution** affecting the Satilla River.

We are active in environmental coalitions that help enforce existing laws, and shape new legislation and rules that affect water and habitat throughout the Satilla River, from headwaters to estuary. Our gala and auction help raise the necessary funds to accomplish our mission.
